Dear Students,

The first thing I want to do is congratulate you for your strength and perseverance during the last year. Your engagement with your teachers alongside your work ethic is to be commended. These are unprecedented times and you did not choose to for this to happen. As you are fully aware, the government has cancelled exams in the normal sense this year and has asked schools again to submit Centre Assessment Grades (CAGs) instead.

Last year we put an accurate, rigorous and fair system in place that fully reflected what our students would have achieved. This year we have done the same, we have put together an accurate, **rigorous and fair** system for you, a system where you have the opportunity to demonstrate what you can achieve.

We have 3 assessment points, the first being the current mocks, the second a series of class based assessments that may include practicals and NEAs and the final one being an assessment week in May. The Assessment Points have been designed to give students multiple opportunities to show the progress they have made between each point. Further detailed information from each subject is contained within this booklet.

Schools are all taking different approaches that reflect their students and situation. This is why the exams have been cancelled so that each school can put in place what is best for their year groups who were expecting to take their examinations this Summer. You have spent the last two years learning and progressing throughout all your courses and now is the time to show your learning.

This booklet will explain what each of your subjects is doing and how you are going to be assessed. Every subject is unique and they have planned what is best for each individual subject taking into account what has been learned, what needs to be assessed and any impact lockdown has had on your learning.

Your work will be assessed over the coming months, moderated internally and externally by exam trained staff to ensure full accuracy of all grades awarded. The most important thing now is for you to continue to work hard, reflect on your teacher's feedback and demonstrate what grade you deserve. JCQ will be expecting us to send all 3 pieces of evidence to them in the event of either a request as part of the QA process or an appeal from a student and when as staff we apply our final grade we may in some cases use the third Assessment Point to assist with our final decision.

Year 10 – Hospitality & Catering

Introduction to course

These assessment points will include Unit 1 only, this is 40% of the final grade. Unit 2 will be completed in Year 11.

Each assessment point for Unit 1 will be broken down into 3 sections.

Assessment Point 1

When will they be assessed?

Week commencing 12th April 2021

What will be assessed?

Section A will include:

LO1 Understand the environment in which hospitality and catering providers operate

LO2 Understand how hospitality and catering provision operates

Section B will include:

LO3 Understand how hospitality and catering provision meets health and safety requirements

LO4 Know how food can cause ill health

Section C will include:

A comprehension question.

How was this assessed?

During an assessment week under examination conditions.

Will there be an opportunity to be assessed on these topics/papers again?

Yes, sections A, B & C will be assessed again at Assessment Point 3 and Section A & B will be assessed again at Assessment Point 2.

What proportion of this assessment will go towards my final CAG?

There are other opportunities to sit parts of these sections again, in order to show any additional progress made over the assessment period, therefore they will be used to inform your final CAG grade.

Assessment Point 2

When will they be assessed?

Week commencing 26th April 2021 in class.

What will be assessed?

Assessment Point 2 will include:

Section A will include:

LO1 Understand the environment in which hospitality and catering providers operate

LO2 Understand how hospitality and catering provision operates

Section B will include:

LO3 Understand how hospitality and catering provision meets health and safety requirements

LO4 Know how food can cause ill health

How will this be assessed?

This will be a classroom based assessment lasting no longer than 40 minutes per lesson, pupils who require extra time will be given the whole of their lesson to complete this.

Will there be an opportunity to be assessed on these topics/papers again?

Yes, sections A and B will be assessed again at Assessment Point 3 this will also include section C.

What proportion of this assessment will go towards my final CAG?

This is the student's second opportunity to increase their mark on these sections, therefore they will be used to inform your final CAG.

Year 10 Religious Studies

Introduction to course

This course is assessed by the students answering questions in 2 assessment papers which would be the same length as an actual paper and a shorter in class assessment which will take place between Assessment Point 1 and 3. 87.5% of the course has been taught to students, and if the course was to proceed as normal with external exams set by the exam board 100% of the course would have been delivered.

Assessment Point 1

When will they be assessed?

Week commencing 12th April 2021.

What will be assessed?

On this paper students will be assessed on Christian Beliefs, Christian Practices and two themes from the following four: Religion Peace and Conflict, The Existence of God, Religion Crime and Punishment and Religion Relationships and the Family.

How will this be assessed?

During an assessment week under examination conditions via a 105 minute paper.

Will there be an opportunity to be assessed on these topics/papers again?

Questions relating to Christian Practice or Christian Belief will only be assessed at this point. However, this does not mean that students are disadvantaged, please read the 'What proportion of this assessment will go towards my final CAG?' for further clarity. There will be further opportunities for students to answer questions relating to Religion Peace and Conflict, The Existence of God, Religion Crime and Punishment and Religion Relationships and the Family. Students will always be given a choice from the four topics, so if they wish, they could revise just two topics and answer questions relating to those topics in all three assessment points.

What proportion of this assessment will go towards my final CAG?

Across all three assessment points students will answer a total of 10 unit questions:

Christian Practice x1

Christian Belief x1

Islamic Practice x1

Islamic Belief x1

Religious Education (cont'd)

Then 6 from, Religion Peace and Conflict, The Existence of God, Religion Crime and Punishment and Religion Relationships and the Family. (please take note of the advice in 'Will there be an opportunity to be assessed on these topics/papers again?' (above) in order to make sure that revision is targeted.

Students will have their grades calculated from the highest scoring 8 questions. This means that the two lowest scoring questions will be discounted.

The result of this, is that students will have some of their marks from the sections relating to Christian Practice, Christian Belief, Islamic Practice, Islamic Belief (which reflects what would have happened is normal exams had taken place) but students will also be given a choice of topic from the themes section. However, if students do not do well in the sections relating to pure Christianity and Islam, marks can be discounted, therefore not lower the overall grade.

Assessment Point 2

When will they be assessed?

Week commencing 26th April 2021.

What will be assessed?

Religion Peace and Conflict

The Existence of God

Religion Crime and Punishment

Religion Relationships and the Family.

Students will sit a 55 minute exam. Students will have a choice from 4 questions (1 relating to each of the topics listed above) but will only answer 2. The 2 questions which students answer will be entirely at their own discretion.

Year 10 Creative iMedia

Introduction to course

This course is assessed by three units, (R081, R082 and R086):

- R081 is assessed by examination.
- R082 and R086 are NEA (non exam assessment).

Units assessed in Year 10

Units R081 and R082 have been entered for assessment in Year 10 and students will receive a CAG **for each unit** in the Autumn term of Year 11.

Unit R086 will be completed in Year 11 and sent for external moderation in Summer 2022.

How the final grade will be calculated

This qualification follows a different CAG process to the other Year 10 CAGs, as the whole qualification is not taken in Year 10. The reporting will also differ for this reason.

You will receive two CAGs for iMedia, one for R081 and one for R082.

The CAG grades from R081 and R082 will be used along with the grade you achieve for R086 (in Year 11) to calculate the final grade, which will be received in Summer 2022. Each unit has an equal weighting (33.33%).

You will have one opportunity to sit R081 again, at Assessment Point 3.

Assessment Point 2

What will be assessed?

R082

How will this be assessed?

NEA (non exam assessment). The final deadline for revisions will be Friday, 9th July. Task 1, Task 2 and most of Task 3 of R082 will be completed for assessment. This will be used to calculate your R082 CAG.

Will there be an opportunity to be assessed on these topics/papers again?

No. This is from your non exam assessment for R082. There will be ongoing opportunities to get feedback and make improvements before the final submission.

Assessment Point 3

When will this be assessed?

Week commencing 5th July 2021.

What will be assessed?

R081

How will this be assessed?

You will be assessed under examination conditions.

Will there be an opportunity to be assessed on these topics again?

No, this is the final assessment point for R081 CAG grade. This is the second opportunity to increase your final CAG for R081, therefore the highest mark of your two opportunities will be used to inform your final R081 CAG.
